 Motion declared carried.

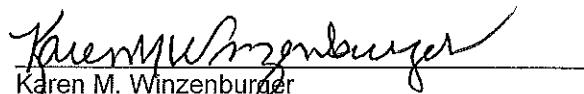
**Hiring Janitor – Jessica Martinez**
