SCHEDULE "E"

NO PARKING ZONES AND LIMITED PARKING

In accordance with the provisions of **Section 24-6-4**, the following no-parking or limited parking streets are hereby established, to-wit:

Parking lot (area of land west of Illinois Central Gulf Railroad and east of Appleknocker Dr.) that is leased by the Village is closed to public use between the hours of **11:00 P.M.** and **5:00 A.M.** (**#786**)

West Side of Front St. between Poplar St. and the bridge over the railroad tracks. (**#75**)

Parking lot (area of land east of Illinois Central Gulf Railroad and west of Front St. that is leased by the Village) shall be closed to public use between the hours of **11:00 P.M.** and **5:00 A.M.** (**#130**)

West side of Front St. beginning at the North side of W. Maple St. for a distance of **ninety (90) feet** north. (**#142**)

Within **twenty (20) feet** of pavement from E. Maple St. south to south corporate limits on S. Front St. (U.S. Route 51). (**#161**)

Street side parking on west side of Appleknocker Dr. between Walnut and Locust St. shall be closed to public use between the hours of **six o'clock (6:00) P.M.** and **six o'clock (6:00) A.M.** except during school activities, field sports, school sports, and civic activities. (**#162**)

On the east or west side of S. Appleknocker Dr. from W. Hickory south to the south corporate limits. (**#216**)

On W. Walnut St. (**#885**)

On N. Centennial St. from the intersection of N. Centennial and W. Walnut St. north to the corporate limits. (**#274**)

Street side parking on east side of N. Appleknocker Dr. between Walnut and Locust St. shall be prohibited between the hours of **eight o'clock (8:00) A.M.** and **four o'clock (4:00) P.M.** Monday through Friday. (**#294**)

Parking will be limited to **three (3) hours** on Locust St. from N. Centennial to Oak St. including the parking area of the Cobden Community Park during the hours of **8:00 A.M.** to **4:00 P.M.** Monday through Friday unless the person operating the vehicle is using the Cobden Community Park. (**#745**)
