

ORDINANCE NO. 2018-974

AN ORDINANCE AMENDING SECTION 38-2-1 (D) OF THE REVISED CODE OF ORDINANCES FOR THE VILLAGE OF COBDEN, ILLINOIS

BE IT ORDAINED BY THE PRESIDENT AND VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS, THAT:

**SECTION 1.** Section 38-2-1 (D) of the Revised Code of Ordinances of the Village of Cobden, Union County, Illinois, is amended to read as follows:


(D) **Using Utilities Without Paying.** Any person using utility services from the Village without paying therefor, or who shall be found guilty of breaking any water or gas meter or appurtenances, or by-pass the water or gas meter, shall be guilty of a misdemeanor and upon conviction, shall be fined a sum as is provided in **Section 1-1-20** of this Code. **(720 ILCS 5/16-14) (Ord. No. 457; 09-20-93)**

Any person whose gas or water meter is found to have been turned on by anyone other than a Village Employee will have the amount of **One Hundred Dollars (\$100.00)** added to their regular bill upon discovery of first offense. If a subsequent violation occurs, the amount of **Two Hundred Dollars (\$200.00)** will be added to their regular bill. Upon third offense and each offense thereafter, the amount of **Three Hundred Dollars (\$300.00)** will be added to their regular bill.

**SECTION 2.** That all ordinances and parts of ordinance in conflict herewith are expressly repealed.

**SECTION 3.** This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, as provided by the Illinois Compiled Statutes, Chapter 65; Section 5/1-2-4.
