AN ORDINANCE AMENDING SECTION 16-1-3 OF THE REVISED CODE OF ORDINANCES FOR THE VILLAGE OF COBDEN, ILLINOIS

BE IT ORDAINED BY THE PRESIDENT AND VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS, THAT:

SECTION 1. Section 16-1-3 of the Revised Code of Ordinances of the Village of Cobden, Union County, Illinois, is amended to read as follows:

16-1-3 GAS SUPERINTENDENT. It shall be the duty of the Gas Superintendent to manage and control all aspects of the day-to-day operation of the Gas System and to recommend to the Village Superintendent, Mayor and Utilities Committee the needs of the Gas System.

SECTION 2. That all ordinances and parts of ordinance in conflict herewith are expressly repealed.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, as provided by the Illinois Compiled Statutes, Chapter 65; Section 5/1-2-4,
