

ORDINANCE NO. 2021-1026

AN ORDINANCE TO AMEND SECTION 9-3-6 OF THE VILLAGE OF COBDEN, ILLINOIS REVISED CODE OF ORDINANCES

BE IT ORDAINED BY THE PRESIDENT AND VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS, THAT:

Section 1. Section 9-3-6 of the "Revised Code of Ordinances of the Village of Cobden" shall be amended to read as follows:

9-3-6 DONATIONS, GIFTS AND DUTIES OF BOARD. The Board of Managers is hereby authorized and empowered to receive in trust from the proprietors or owners of any lot or burial space in the Cobden Cemetery or from any person interested in the maintenance of the same, any gift, donation, devise or bequest of money or any funds, securities, or property of any kind, in perpetual trust, for the maintenance, care, repair, and upkeep or ornamentation of the Cobden Cemetery, or any lot or lots, or grave or graves in said Cemetery. The Board of Managers shall have the right to convert the property into money and shall invest same in good, safe, interest-bearing securities. The Board of Managers shall at all times maintain at least One Hundred Thousand Dollars (\$100,000.00) as principal in said trust fund, and said sum shall be kept intact, and perpetually invested, and any excess of principal above said sum and the income received from the investment of the principal of said trust fund shall perpetually be applied for the care of the cemetery lots or the care and maintenance of the cemetery, as shall be approved and directed by the Board of Managers.

Section 2. That all ordinances and parts of ordinance in conflict herewith are expressly repealed.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, as provided by the Illinois Compiled Statutes, Chapter 65; Section 5/1-2-4.
