**AN ORDINANCE TO DISPOSE OF CERTAIN SURPLUS PROPERTY BELONGING TO THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS**

**WHEREAS**, the following items are no longer necessary, useful to, or for the best interests of the Village of Cobden, and

**WHEREAS**, the Illinois Compiled Statutes provides that the Village Board may authorize by ordinance the sale of such personal property, and

**NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE BOARD OF THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1.** That the following described items may be sold to the highest bidder:

- 2011 Ford Explorer  
Note: Vehicle only. All equipment including but not limited to use in service as a police vehicle has been removed.
- 2013 Chevrolet Impala  
Note: Vehicle only. All equipment including but not limited to use in service as a police vehicle has been removed.
- Case 360 Trencher
- Swenson salt spreader
- Playground slide and climber
- Electric panels
- Snapper 4.5 HP push mower
- 15 HP generator
- Backpack leaf blower Stihl
- Handheld leaf blower Stihl

**SECTION 2.** That the Village President, Village Clerk or Chief of Police are hereby authorized to convey the title of the listed vehicles to the successful bidder.

**SECTION 3.** That the Village of Cobden may reject any or all bids.

**SECTION 4.** That the above property will be advertised for sale on the Village's website along with a notice included in the Village June utility bills. The items will be available for viewing from June 3 – June 14, 2024 by contacting the Village Hall for an appointment. Sealed bids will be accepted at the Village Hall until 5:00 p.m. on Monday, June 17, 2024, to be opened at the regular Village Board meeting on June 17, 2024.

**SECTION 5.** That this ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form as provided by law.
