## ORDINANCE NO. 930

### AN ORDINANCE TO DISPOSE OF CERTAIN SURPLUS PROPERTY BELONGING TO THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS

**WHEREAS**, the following items are no longer necessary or useful for the operation of the Village of Cobden or financially feasible for the Village of Cobden to insure and maintain, and

**WHEREAS**, the Illinois Compiled Statutes provides that the Village Board may authorize by ordinance the sale of such personal property, and

**NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE BOARD OF THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS AS FOLLOWS:**

**SECTION 1.** That the following described items may be sold to the highest bidder. The minimum acceptable bid for the vehicles is Five Hundred Dollars (\$500.00).

1. Sewer jetter


**SECTION 2.** That the Village President, Village Clerk or Chief of Police are hereby authorized to convey the title of the listed vehicles to the successful bidder.

**SECTION 3.** That the Village of Cobden may reject any or all bids.


