#### Ordinance No. 2021-1010 - Holidays

Motion was made by Brumleve, seconded by Sellars, to pass and adopt Ordinance No. 2021-1010 – AN ORDINANCE TO AMEND SECTION 11-5-2 OF THE VILLAGE OF COBDEN, REVISED CODE OF ORDINANCES. Upon roll call, the vote was:

Motion declared carried. This Ordinance provides that the Village Hall will not open on Christmas Eve but the complete holiday will be observed as in other departments of the Village workforce.

#### **Hiring Police Officer**

Michael Winters and Benjamin Godinez were once again interviewed by the Board. Motion was made by Brumleve, seconded by Hackethal, to hire Benjamin Godinez with the following provisions:

- Rate of pay \$15.50 per hour
- Reporting to duty as soon as possible
- Probation will be in effect until three months following successful completion of Police Academy
- A contract will be required for a five year commitment. If he leaves Village employment prior to the end of the five-year period, he will be required to reimburse the Village for the cost of training, uniforms and equipment on a pro-rated basis.

#### <u>Digital Radio Communications for Public Safety</u>
