ORDINANCE NO. 2019 – 997

AN ORDINANCE TO DISPOSE OF CERTAIN SURPLUS PROPERTY BELONGING TO THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS

WHEREAS, the following items are no longer necessary or useful for the operation of the Village of Cobden or financially feasible for the Village of Cobden to insure and maintain, and

WHEREAS, the Illinois Compiled Statutes provides that the Village Board may authorize by ordinance the sale of such personal property, and

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE BOARD OF THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. That the following described items may be sold to the highest bidder:

1. Various electric boxes (5 disconnect) (1 power panel)
2. 3 air blower motors
3. 5 electric motors
4. 1 large gear box
5. 1993 Ford F-150 2 wd
6. Onan 100 kw generator
7. 11 trimmers (some run, some are for parts)
8. Ford Crown Victoria Interceptor Police Squad Car (VIN 159517)
9. Ford Crown Victoria Interceptor Police Squad Car (VIN 159519)
10. 1998 Ford Expedition Eddie Bauer Edition

SECTION 2. That the Village President, Village Clerk or Chief of Police are hereby authorized to convey the title of the listed vehicles to the successful bidder.

SECTION 3. That the Village of Cobden may reject any or all bids.

SECTION 4. That the above property will be advertised for sale by sending an insert in the September 2019 Village utility bills, on the Village's website and by advertisement in Monday's Pub. Items will be available for viewing September 4th through September 13th at the Village garage by contacting the Village Hall. Sealed bids will be accepted at the Village

Hall until 5:00 p.m. on Monday, September 16, 2019, to be opened at the regular Village Board meeting on September 16, 2019.

SECTION 5. That this ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form as provided by law.
