ORDINANCE NO. 2021-1018

AN ORDINANCE TO AMEND SECTION 1-2-21(B) OF THE REVISED CODE OF ORDINANCES FOR THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS

BE IT ORDAINED BY THE PRESIDENT AND VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS, THAT:

SECTION 1. Section 1-2-21(B) of Ordinance No. 1 entitled "Revised Code of Ordinances of 1974" is amended to read as follows:

1-2-21 MUNICIPAL OFFICERS - REGULATIONS.

(A) **Effect.** The provisions of this Division shall apply alike to all officers and employees of the Village regardless of the time of creation of the office or position or the time of the appointment of the officer or employee.

(B) **Qualifications; Appointive Office.**

- (1) No person shall be eligible for any appointive municipal office unless that person is a qualified elector of the municipality or otherwise provided by law.
- (2) The residency requirements do not apply, however, to municipal engineers, health officers, attorneys, or other officers who require technical training or knowledge, to appointed Village Treasurers, appointed Village Clerks, appointed Deputy Village Clerks or to appointed Village Collectors. **(65 ILCS 5/3.1-10-6)**

SECTION 2. That all ordinances and parts of ordinance in conflict herewith are expressly repealed.


SECTION 3. This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, as provided by the Illinois Compiled Statutes, Chapter 65; Section 5/1-2-4.
