

ORDINANCE NO. 2023-1039

AN ORDINANCE AMENDING SECTION 38-3-79 OF THE REVISED CODE OF ORDINANCES FOR THE VILLAGE OF COBDEN, ILLINOIS

BE IT ORDAINED BY THE PRESIDENT AND VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS, THAT:

SECTION 1. Section 38-3-79 of the Revised Code of Ordinances of the Village of Cobden, Union County, Illinois, is amended to read as follows:

38-3-79 WATER RATES. The monthly charge for water service shall be as follows:

For service within the corporate limits:

First 1,500 gallons \$15.00 (minimum)
All over 1,500 gallons..... \$ 7.50 per 1,000 gallons
Minimum monthly charge..... \$15.00

For service outside the corporate limits:

First 1,500 gallons \$15.75 (minimum)
All over 1,500 gallons..... \$ 8.00 per 1,000 gallons
Minimum monthly charge..... \$15.75

For service to Alto Pass Water District:

First 1,500 gallons \$500.00 (minimum)
All over 1,500 gallons..... \$ 6.00 per 1,000 gallons
Minimum monthly charge..... \$500.00

All purchasers of bulk water at the bulk water sales dispenser shall pay the rate of Twenty-Five Cents (\$0.25) per fifty (50) gallons. All bulk water is to be dispensed into closed topped containers sealed in such a manner to prevent spillage and removed from the site. Purchasers must abide by the rules for purchasing of bulk water as adopted by the Village Board of Trustees.

SECTION 2. Water rates set forth in this ordinance were effective with the March 1, 2023 utility billing (See Ordinance No. 2023-1038 and Village Board minutes February 21, 2023).

SECTION 3. That all ordinances and parts of ordinance in conflict herewith are expressly repealed.




