ORDINANCE NO. 2023-1043

AN ORDINANCE AMENDING SECTION 21-3-1 OF THE REVISED CODE OF ORDINANCES FOR THE VILLAGE OF COBDEN, ILLINOIS

BE IT ORDAINED BY THE PRESIDENT AND VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS, THAT:

SECTION 1. Section 21-3-1 of the Revised Code of Ordinances of the Village of Cobden, Union County, Illinois, shall be amended to read as follows:

21-3-1 HOURS.

(A) All such places in which alcoholic liquors are sold at retail in the Village shall not offer to sell, give, or deliver any liquor or intoxicating beverage, between the hours of 12:00 o'clock A.M. (midnight) and 6:00 o'clock A.M. on Monday through Friday, both inclusive, or between the hours of 1:00 o'clock A.M. and 6:00 o'clock A.M. on Saturday; or between the hours of 1:00 o'clock A.M. and 12:00 o'clock P.M. (noon) on Sunday with the exception of Class D licensed premises which are permitted to serve alcohol beginning at 8:00 o'clock A.M. on Sunday until 12:00 A.M. on Monday.

(B) The licensee shall not permit any customer or patron to remain within the place of business longer than one-half (1/2) hour after the aforesaid closing times.

(C) No alcoholic liquor shall be sold and all Class "A" licensed premises must remain closed at all other times other than those above specified. Any holder of a retail liquor license or his agent or employee who violates the provisions of this Chapter in regulating the legal hours of operation shall, upon conviction, be fined as provided in Section 1-1-20 of this Code.

(D) The times referred to above shall mean Daylight Savings Time when the same is in effect in the Village, and upon the cessation of Daylight Savings Time, shall be Central Standard Time.

(E) An extra hour of business may be granted by the Mayor on New Year's Eve

SECTION 2. That all ordinances and parts of ordinance in conflict herewith are expressly repealed.

SECTION 3. This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, as provided by the Illinois Compiled Statutes.
