AN ORDINANCE TO AMEND SECTION SCHEDULE "E" OF CHAPTER 24 OF THE REVISED CODE OF ORDINANCES OF THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS

BE IT ORDAINED BY THE PRESIDENT AND VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS, THAT:

Section 1. Schedule "E" of Chapter 24 of the Village of Cobden Revised Code of Ordinances shall be amended to read as follows:

SCHEDULE "E"

"NO PARKING ZONES AND LIMITED PARKING"

In accordance with the provisions of Section 24-6-4, the following no parking or limited parking streets are hereby established, to-wit:

Parking lot (area of land west of Illinois Central Railroad and east of Appleknocker Drive) that is leased by the Village is closed to public use between the hours of 11:00 p.m. and 5:00 a.m. (#786)

West Side of North Front Street between East Poplar Street and the bridge over the railroad tracks. (#75)

Parking lot (area of land east of Illinois Central Railroad and west of South Front Street that is leased by the Village of Cobden) be closed to public use between the hours of 11:00 P.M. and 5:00 A.M. (#130)

West side of South Front Street beginning at the North side of West Maple Street for a distance of ninety (90') feet north. (#142)

Within twenty (20) feet of pavement from East Maple Street south to south corporate limits on South Front Street (Old Hwy 51). (#161)

Street side parking on west side of Appleknocker Drive between Walnut and Locust Street shall be closed to public use between the hours of six o'clock (6:00) P.M. and six o'clock (6:00) A. M. except during school activities, field sports, school sports, and civic activities. (#162)

On the east or west side of South Appleknocker Drive from West Hickory south to the south corporate limits. (#216)

On West Walnut Street (#885)

On North Centennial Street from the intersection of North Centennial and West Walnut Street north to the corporate limits. (#274)

Street side parking on east side of North Appleknocker Drive between Walnut and Locust Streets shall be prohibited between the hours of eight o'clock (8:00) A.M. and four o'clock (4:00) P.M. Monday through Friday. (#294)

Parking will be limited to three (3) hours on Locust Street from North Centennial to Oak Street including the parking area of the Cobden Community Park during the hours of 8:00 a.m. to 4:00 p.m. Monday through Friday unless the person operating the vehicle is using the Cobden Community Park.


On North Centennial Street from the intersection of West Poplar Street north to Oak Street.

Section 2. That all ordinances and parts of ordinance in conflict herewith are expressly repealed.

Section 3. This ordinance shall be in full force and effect upon its passage, approval, and adoption as provided by law.

Section 4. This ordinance shall be published in pamphlet form by the Village Clerk.
