

ORDINANCE NO. 2016-934

AN ORDINANCE TO REVISE SCHEDULE "F" OF CHAPTER 24 OF THE VILLAGE OF COBDEN REVISED CODE OF ORDINANCES.

BE IT ORDAINED BY THE VILLAGE PRESIDENT AND VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. That Schedule "F" of Chapter 24 of the Village of Cobden Revised Code of Ordinances shall be amended to read as follows:

**SCHEDULE "F"
PERSON WITH DISABILITIES PARKING**

The following locations shall be set aside for designated areas for Person with Disabilities parking. The number in parentheses indicates the number of designated parking areas.

- A. In front of the following churches:
 - First Baptist Church – 200 South Walker Street – (6)
 - St. Joseph Church – 103 North Centennial Street – (2)
 - Congregational Church – 115 West Ash Street – (1)

- B. Other locations:
 - Cobden Post Office – 113 South Appleknocker Drive – (1)
 - Cobden Community Park – Locust Street – (2)
 - Illinois Migrant Council Learning Center – 111 South Appleknocker Drive (1)
 - Village Hall – 112 East Maple Street – (1)

SECTION 2. That except as hereby modified and changed, the Village of Cobden Revised Code of Ordinances shall remain the same and in full force and effect.

SECTION 3. That all ordinances or parts of ordinances in conflict herewith are expressly repealed.


