

ORDINANCE NO. 2016-941

AN ORDINANCE TO AMEND SECTION 1-3-1 OF ORDINANCE NO. 1 ENTITLED "REVISED CODE OF ORDINANCES OF 1974", ENACTED ON THE 15TH DAY OF JULY, 1974.

BE IT ORDAINED BY THE PRESIDENT AND VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF COBDEN, UNION COUNTY, ILLINOIS, THAT:

Section 1. Section 1-3-1 of Ordinance No. 1 entitled "Revised Code of Ordinances of 1974", shall be amended to read as follows:

ARTICLE III – SALARIES

1-3-1 OFFICIAL SALARIES. The salaries of the elected and appointed Village officials shall be as follows:

(A) **Mayor.** The Mayor shall receive an annual salary of **Two Thousand Five Hundred Dollars (\$2,500.00) to be paid in quarterly payments of Six Hundred Twenty-Five Dollars (\$625.00).** The salary shall not be increased during the two (2) months preceding the Village election.

(B) **Clerk.** The Village Clerk shall receive an annual salary of Two Thousand Dollars (\$2,000.00) to be paid in quarterly payments of Five Hundred Dollars (\$500.00).

(C) **Budget Officer.** The Budget Officer shall receive an annual salary of **One Thousand Dollars (\$1,000.00) to be paid in quarterly payments of Two Hundred Fifty Dollars (\$250.00).**

(D) **Trustees.** Trustees shall be paid at the rate of **Forty Dollars (\$40.00) per meeting** which shall be paid quarterly. All members shall be allowed two (2) absences in each year for which compensation will be paid. Trustees serving active duty in the United States military forces shall be paid for meetings held during their period of active duty.

(E) **Treasurer.** The Village Treasurer shall receive an annual salary of One Thousand Dollars (\$1,000.00) to be paid in quarterly payments of Two Hundred Fifty Dollars (\$250.00).

(F) **Zoning Administrative Officer.** The Zoning Administrative Officer shall receive an annual salary of One Thousand Dollars (\$1,000.00) to be paid in quarterly payments of Two Hundred Fifty Dollars (\$250.00). (See 65 ILCS Sec. 5/3.1-50-5; 5/3.1-50-10; 5/3.1-50-15) (#2016-939; 05/02/2016)

(G) **Deputy Clerk.** The Deputy Village Clerk shall receive an annual salary of **Nine Hundred Sixty Dollars (\$960.00) to be paid in quarterly payments of Two Hundred Forty Dollars (\$240.00).**

Section 2. That all ordinances and parts of ordinance in conflict herewith are expressly repealed.

Section 3. This ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form, as provided by the Illinois Compiled Statutes, Chapter 65; Section 5/1-2-4.
