

38-3-79 WATER RATES. The monthly charge for water service shall be as follows:

For service within the corporate limits:
First 1,500 gallons \$17.00 (minimum)
All over 1,500 gallons..... \$ 8.00 per 1,000 gallons
Minimum monthly charge..... \$17.00

For service outside the corporate limits:
First 1,500 gallons \$17.75 (minimum)
All over 1,500 gallons..... \$ 8.50 per 1,000 gallons
Minimum monthly charge..... \$17.75

For service to Alto Pass Water District:
First 1,500 gallons \$500.00 (minimum)
All over 1,500 gallons..... \$ 6.50 per 1,000 gallons
Minimum monthly charge..... \$500.00

38-4-79 SEWER RATES AND ADJUSTMENTS.

A. **SEWER RATES.** The monthly charge for sewer service shall be as follows:

For service within the corporate limits:
First 1,500 gallons \$23.00 (minimum)
All over 1,500 gallons..... \$ 8.00 per 1,000 gallons
Minimum monthly charge.....\$23.00

For service outside the corporate limits:
First 1,500 gallons \$24.00 (minimum)
All over 1,500 gallons..... \$ 8.50 per 1,000 gallons
Minimum monthly charge.....\$24.00

B. **ADJUSTMENT FOR SWIMMING POOLS.** A customer may request one sewer billing adjustment per year (no exceptions – only one per twelve month period) when filling a swimming pool. The average sewer costs for the previous six months will be calculated by the billing clerk and the customer’s sewer charge when filling the pool will be adjusted down to that monthly rate. The customer must request the adjustment upon receipt of the utility bill for that period. The adjustment will not carry over from one meter reading period to the next.

C. **ADJUSTMENT FOR WATER LEAKS.** A customer may request a sewer billing adjustment for the sewer charge after experiencing a water leak that did not enter the sewer system that is verified by a Village employee and approved by the Village Board of Trustees. The average sewer costs for the previous six months will be calculated by the billing clerk and the customer’s sewer charge will be adjusted down to that monthly rate. The customer must request the adjustment upon receipt of the utility bill for that period.

16-3-1 GAS RATES.

(A) Rates and charges for the use and services of the municipal gas utility shall be based upon the quantity of gas used by each customer, as measured by the gas meter, and said charges shall be computed on a monthly basis at the following rates:

For service within the corporate limits:

0 ccf..... \$20.00 (minimum)
All over 0 ccf..... \$ 1.50 per ccf
Minimum monthly charge.....\$20.00

For service outside the corporate limits:

0 ccf..... \$22.00 (minimum)
All over 0 ccf..... \$ 1.55 per ccf
Minimum monthly charge.....\$22.00

(B) All billings shall be subject to any tax imposed on the sale or distribution of natural gas by the Village. Any such tax shall be added to the rates for service by computation of a percentage factor equivalent to the effect of the tax. In like manner, any change in the total monthly cost of natural gas (including transportation costs) to the Village from its pipeline supplier shall be applied to the rates for service by computation of a percentage cost factor or unit cost per dth. The base cost for this computation is Eight Dollars (\$8.00) per dth. A credit adjustment will be computed if the monthly cost of natural gas to the Village is below **Five Dollars (\$5.00) per dth.**

(C) Customers who are charged a minimum bill with zero usage, will not be subject to a rate adjustment.

TRASH RATES

17-1-2 RATES ESTABLISHED.

A. There are hereby established rates and charges for the residential use and service of the Trash Collection Contractor of the Village.

Period	Rates
October 1, 2022 - September 30, 2023	\$19.94 per month per household
October 1, 2023 - September 30, 2024	\$20.64 per month per household
October 1, 2024 - September 30, 2025	\$21.36 per month per household
October 1, 2025 - September 30, 2026	\$22.11 per month per household
October 1, 2026 - September 30, 2027	\$22.88 per month per household

B. Commercial users will be responsible for their own arrangement with "The Contractor".
